We use your Personal Information only for providing and improving the Site and Service. By using the Site or Service, you agree to the collection and use of information in accordance with this policy.

## 1. Policy

- 1.1. Meng-Jiang is committed to protecting your privacy online. We are also committed to providing you with the very best experience we can offer on our website. In order to enhance your experience at our site we gather certain personal information about you that helps us customize our content to your tastes and preferences. Please read the following policy to understand how your personal information will be treated as you make full use of our Web site. This policy may change from time to time so please check back periodically.

## 2. What information do we collect ?

- 2.1. Meng-Jiang collects information in several ways from different parts of our Web site. Meng-Jiang collects some personal information when you initially access our site. We may ask for your name, email address, and other personal information depending on your interaction with the website. - 2.2. ## 3. What are "Cookies" and how do we use them ?

- 3.1. Meng-Jiang uses "Cookies" to track and record your preferences and activity on our website. Cookies are small bits of data that are sent to your browser and stored on your computer's hard drive. Your cookie may be set at various times during your interaction with our Web site. It is updated from time to time as you access the many different portions of our Web site. Each time you access our site, our server may deliver certain customized information to you based on the data stored in your cookie.
- 3.2. We also collect IP addresses for system administration for future marketing and demographics analysis efforts. The better we understand our market, the better we may be positioned to adjust our services accordingly.

## 4. What do we do with the information we collect?

- 4.1. Meng-Jiang's primary goal in collecting personal information is to provide you, the user, with a customized experience on our website. The information we collect (including information contained in your cookie) may be used to provide such capabilities as personalization services, interactive communications, online shopping, and personalized

communication.   - 5.2.2. was explicitly approved for release by you, but only to the extent of and subject to such conditions as may be imposed in such authorization.
